ADDENDUM No. 1 PREQUALIFICATION OF BIDDERS FOR PREQUALIFIED CONTRACTORS LIST FOR WATER, SEWER AND WATER RECLAMATION PROJECTS EFECTIVE APRIL 1, 2018 TO JUNE 30, 2021

This Addendum No. 1 to the subject Request for Prequalification of Bidders amends the Part III Project Information section describing the minimum qualifications for Pipelines to allow contractors specializing in a single type of pipeline to be prequalified to bid on the type of pipeline for which the contractor can demonstrate the required minimum experience and the Part IV Reference Questionnaire.

All provisions of and attachments to this Addendum No. 1 are hereby incorporated by reference into the subject RFQ.

1. PREQUALIFICATION OF BIDDERS, PARTS I - V:

PART III. PROJECT INFORMATION – Replace the **Pipelines** – <u>Minimum Qualifications</u> section with the following:

"Minimum Qualifications for General Pipeline Construction

As the Prime Contractor and within the last five years, the firm shall have completed construction of a minimum of 30,000 combined linear feet of 8-inch or larger diameter pipelines. Out of the 30,000 linear feet, the firm shall demonstrate a minimum of 10,000 linear feet of 8-inch or larger diameter pressure pipelines and a minimum of 10,000 linear feet of 8-inch or larger diameter sewer service. This combined experience shall be based upon any combination of the following pipeline materials including cement mortar lined and coated welded steel (AWWA C-200), ductile iron (AWWA C-151), polyvinyl chloride (AWWA C-900, AWWA C-905, or ASTM D-3034), high density polyethylene (HDPE), and/or vitrified clay pipe (ASTM C-700). The firm shall have completed construction (or reached a minimum of 75% completion) of a minimum of three separate pipeline projects meeting the above minimum qualifications within the last five years. Reference projects demonstrating compliance with the above criteria shall be provided to be considered for prequalification for this project category.

Minimum Qualifications for Specialty Pipeline Construction

As the Prime Contractor and within the last five years, the firm shall have completed construction of a minimum of 30,000 linear feet of 8-inch or larger diameter pipelines for a single type of pipeline construction, such as pressurized pipelines or gravity sanitary sewers.

This experience shall be based upon any combination of the following pipeline materials for pressure pipelines including cement mortar lined and coated welded steel (AWWA C-200), ductile iron (AWWA C-151), polyvinyl chloride (AWWA C-900 or AWWA C-905), or high density polyethylene (HDPE), or any combination of the following pipeline materials for gravity sanitary sewer pipelines including vitrified clay pipe (ASTM C-700), polyvinyl chloride (ASTM D-3034), or high density polyethylene (HDPE). The firm shall have completed construction (or reached a minimum of 75% completion) of a minimum of three separate pipeline projects meeting the above minimum qualifications within the last five years. Reference projects demonstrating compliance with the above criteria shall be provided to be considered for prequalification for this project category. The applicant shall be identified as qualified to bid on the type of pipeline construction for which they have demonstrated compliance with the prequalification requirements.

Experience scoring described in the **Part VI Pipelines** section will require 70 out of 100 points for a passing score."
