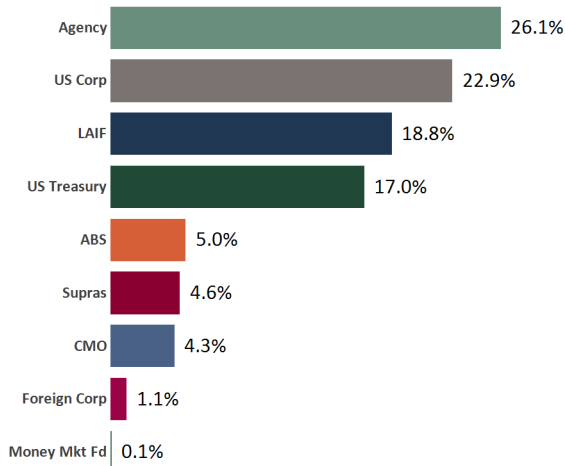

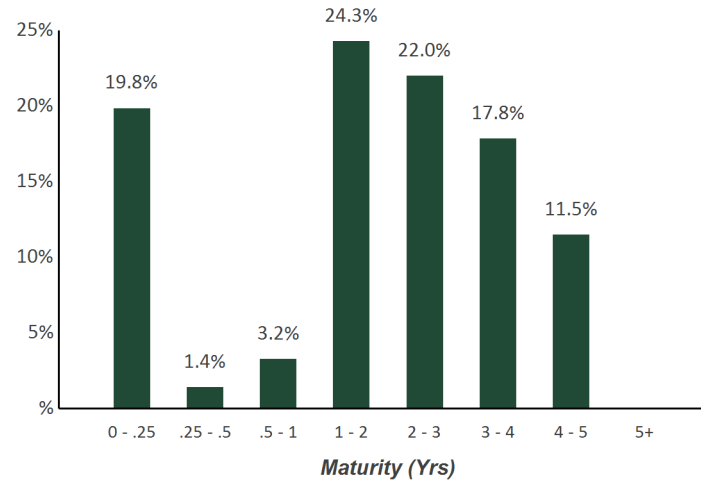

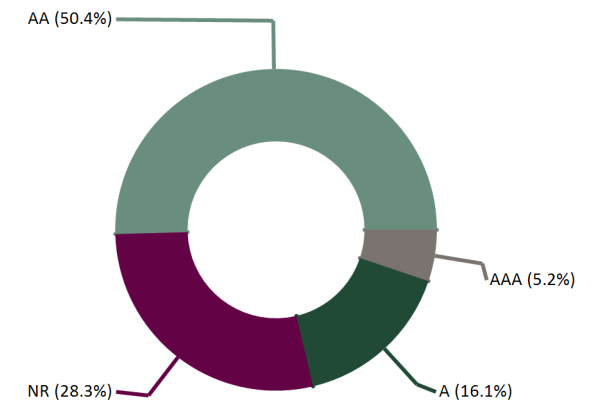
SECTOR ALLOCATION
