PUBLIC NOTICE IS HEREBY GIVEN that the City Council of the City of Corona, California, will conduct a public hearing in the Council Chamber, at the City Hall, 400 South Vicentia Avenue, in said City of Corona, September 18, 2019, at 6:30 p.m., or thereafter, to consider the following:

HRLM2019-0002: An application to nominate a Victorian Hipped Roof Cottage residence built in 1900 located at 506 E. Seventh Street in the Single Family District of the Downtown Corona Revitalization Specific Plan (SP98-01) as a historic landmark on the Corona Register of Historic Resources. (Applicant: Robert and Angela Montanez).

GPA2019-0001: An application to amend the General Plan designation of four properties totaling approximately 0.50 acres from Low Density Residential (LDR) to Office Professional (OP) and establish the Office Professional (OP) and Mixed Use Downtown (MUD) designation on approximately 0.56 acres of public rights-of-way to facilitate the development of a medical office park on a total of 3.48 acres located on the south side of West Sixth Street, between Sheridan Street and Belle Avenue, and consideration of a Mitigated Negative Declaration regarding the potential environmental impacts associated with the proposed project. (Applicant: Richard Boureston, Boureston Development)

SPA2019-0001: An application to amend the Downtown Corona Revitalization Specific Plan (SP98-01) to change the designation of seven properties totaling approximately 1.03 acres from Single Family (SF) and Commercial Services (CS) to Downtown (D) and establish the Downtown District on approximately 0.56 acres of public rights-of-way to facilitate the development of a medical office park on 3.48 acres located on the south side of West Sixth Street, between Sheridan Street and Belle Avenue, and consideration of a Mitigated Negative Declaration regarding the potential environmental impacts associated with the proposed project. (Applicant: Richard Boureston, Boureston Development)

The Planning and Housing Commission at its meeting on August 26, 2019, held a public hearing and at the close of the hearing recommended to the City Council the approval of the above reference application. The public is invited to attend the City Council meeting and comment on the application described above. Due to time constraints and the number of persons wishing to give oral testimony, each speaker will be limited to three minutes. You may wish to make your comments in writing and submit them to the City Clerk for inclusion into the public record. If you challenge any portion of these projects in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered at, or prior to the public hearing.
