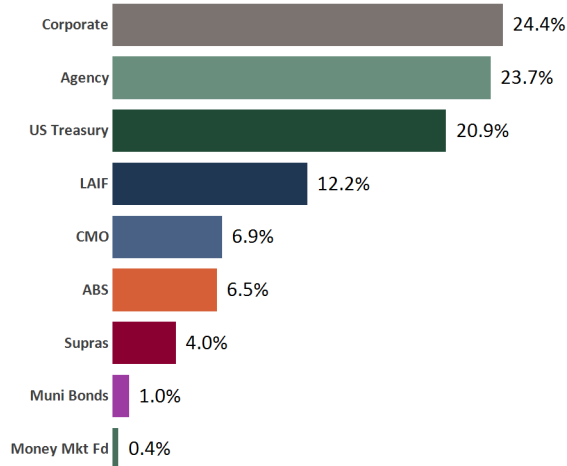

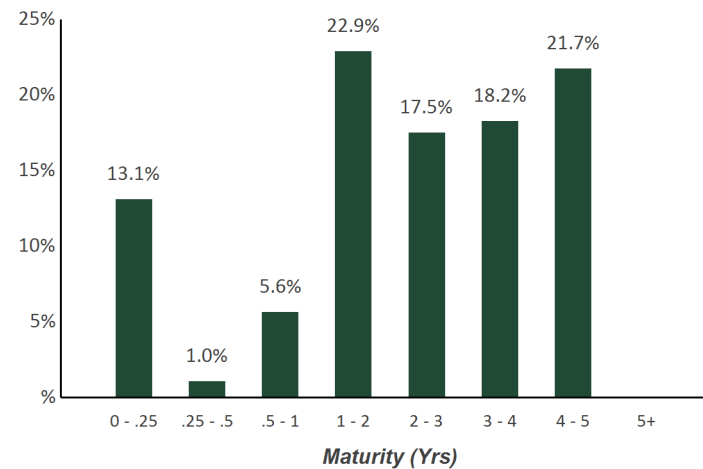

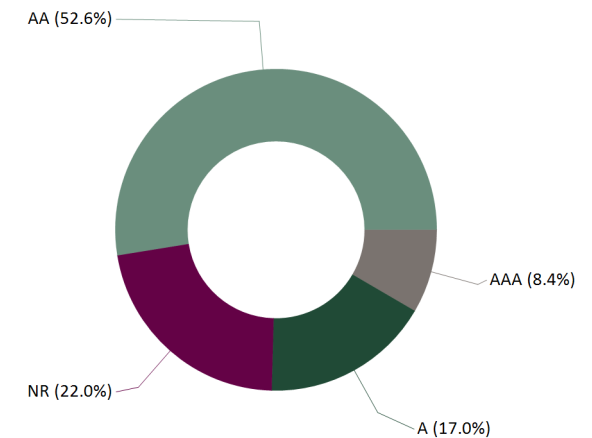
SECTOR ALLOCATION
