PUBLIC NOTICE IS HEREBY GIVEN, that the City of Corona, City of Corona Transit Service has established a Proposed Race-Neutral Overall Disadvantaged Business Enterprise (DBE) Goal of .5% for Federal Fiscal Years 2021 through 2022 in accordance with the requirements of the U.S. Department of Transportation (DOT) 49 C.F.R. Part 26 “Participation by Disadvantaged Business Enterprises in Department of Transportation Financial Assistance Programs” for federally funded contracts. The DBE Goal is applicable to DOT – Federal Transit Administration (FTA) contracting opportunities scheduled to be awarded during the period of October 1, 2020 through September 30, 2023.
