### **NOTICE OF SCHEDULED VACANCIES** **ON BOARD, COMMISSION OR COMMITTEE** **(MADDDY ACT: GOVT. CODE 54974)**

Attached is a list of Board and Commission members whose terms expire December 2020. The filing period for those interested in submitting an application will close on **December 28, 2020**. New appointees will assume office following their appointments and upon being administered the City's loyalty oath.

The Parks & Recreation Commission is comprised of five members, all of whom shall be residents of the City and shall not hold any paid office or employment with the City of Corona. Members each serve four-year terms. The commissioners act in an advisory role to the City Council and make recommendations concerning recreation programs, maintenance and operation of the public park system and the planting, care and removal of trees within the parkways.

The Planning and Housing Commission is comprised of five members, all of whom shall be residents of the City and shall not hold any paid office or employment with the City. Members serve four-year terms. Commissioners act in an advisory role to the City Council and make recommendations pursuant to [California Government Code Section 65100](#).

#### **QUALIFICATIONS:**

Applicants must be a resident of Corona and shall not be an officer or employee of the City or a candidate for the office of the City Council. Never been convicted of a felony.
