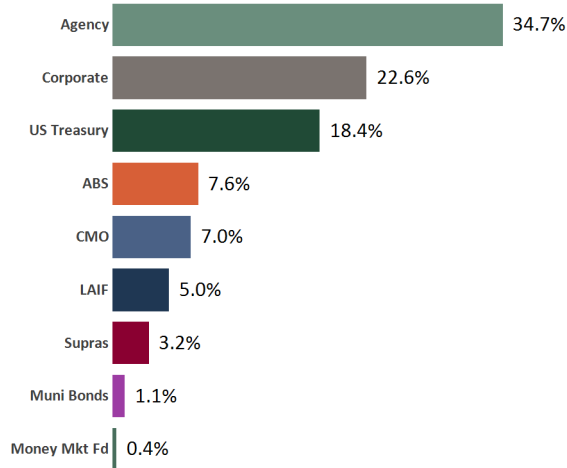

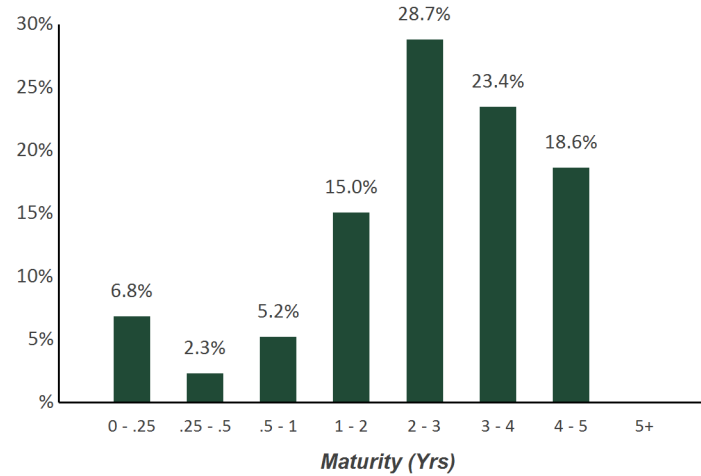

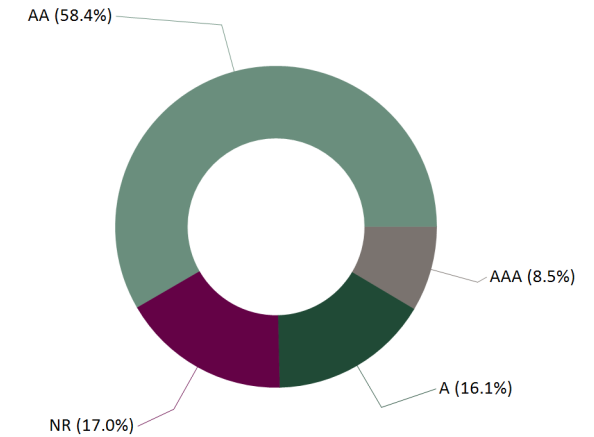
SECTOR ALLOCATION
