## NOTICE OF SCHEDULED VACANCIES ON BOARD, COMMISSION OR COMMITTEE (MADDY ACT: GOVT. CODE 54974)

Attached is a list of Board and Commission members whose terms expire in 2021 on the Library and Board of Trustees. The filing period for those interested in submitting an application will close on **October 25**, **2021**. New appointees will assume office following their appointments and upon being administered the City's loyalty oath.

The Library Board of Trustees is made up of five Corona residents who are not currently city employees or officials. They are appointed by the City Council to serve a three-year term. A trustee is expected to participate in committees as needed, task forces, and attend library events while acting as an advocate for the library in the community. A Library Trustee should be passionate about libraries and the values libraries uphold, supporting all those in their pursuit of lifelong learning without bias.

#### **QUALIFICATIONS:**

Applicants must be a resident of Corona and shall not be an officer or employee of the City or a candidate for the office of the City Council. Never been convicted of a felony.
