1. Applicant is responsible for the planning, design, engineering and construction of all necessary line and service extensions. All facilities shall be designed and constructed in accordance with Utility standards and specifications.
2. Applicant shall submit design drawings and specifications to the Utility for review and approval prior to construction. Applicant shall submit a cash deposit that is required for the Utility's cost to plan check and inspect the electric facilities to be installed for electric service.
3. Applicant is responsible for furnishing, installing, owning and maintaining all conduit and substructures located on the Applicant's premises. All other facilities, including those located along public right-of-ways, shall become the property of the Utility upon acceptance by the Utility.
4. Applicant shall provide information on all electrical equipment that will receive energy from the new electric service. Applicant shall also notify the Utility, in writing, of any changes, deletions, omissions, additions or revisions to the equipment.
