And then as he made his turn into the parking lot, it appeared that he had saw something to make him accelerate quickly. Either the subjects were still fighting, something was not right. So, he accelerated fast. And I felt that there were something on, usually a fight. So, when Corporal Jurado pulled up into the parking lot, Viefhaus parked first and then I got right away. I had my gun drawn, at that moment, I saw a male subject wearing a white t-shirt run by. And he looked like he was in fear of someone, or someone was chasing him. He runs by me, at that time, Corporal Jurado is now gonna be making contact with him. At the same time, I see another two individuals coming towards my direction. And one, uh, falls and then another, uh, is right behind him. I could see him having something in his hand, but I can't make it out. At that time, the other guy, the guy that falls, um, is now turned up on his back. And he's, like, trying to protect himself. The guy immediately jumps on him and starts swinging at him with both hands. And at that same time, I'm thinking he had something in his hand. I didn't know what it was. Somebody in the crowd yells out, "he has a knife." And as I'm advancing up, you know, I'm yelling police officer, Corporal Viefhaus is to my right. And I know that he had his taser out, and I saw him when he, when I was arrived and I saw his taser out. And as I'm trying to approach, I'm, I'm also trying to see what he has in his hands. And I glanced back at him, and I'm looking for the knife because he had one arm tucked on his hand and one arm out. But I just grabbed him, and then I handcuffed him and then I waited. And then I could see that he had the knife was on the floor or the ground next to him. Saturday morning, and, uh, at about, while I was working patrol at Rimpau and Ontario, a call came out of a physical fight in the parking lot of Long John Silver's, and they des—they dispatched two other units to that, so I was pretty close, so I started down Rimpau, yeah, I started down Rimpau towards that call. Uh, before I got to the call then they advised over the radio that they had one subject pinned down in the parking lot. Uh, I thought I was gonna get there first, so I actually put on my leather gloves just in case somebody was bleeding or something I wouldn't get blood on my hands, and, uh, just prior to going 97 on the radio, uh, to advise that I was there, I think it was Bill Serrano and Sergeant Barron, I think their designator was Zebra 40, maybe, today. They said that they were 97 at the call, also. Uh, as I'm driving down El Sobrante and as I'm turning into the driveway of the Long John Silver's Restaurant, I see, uh, I don't know, four or five people standing on the sidewalk near the front door of the restaurant, and then out the corner of my eye, I also see, uh, the Zebra unit's car pulling up, also, uh, pretty much right behind me. So, as I'm pulling into the parking lot, I see one male Hispanic, uh, it was, as far as I understand later, it was an employee that was detained. He was actually walking, uh, it would be eastbound, uh, towards, I said the east part of the restaurant as I'm pulling in, and he had a, uh, had a, uh, look on his face, it looked like he was out of breath. He looked a little disheveled so, uh, I speculated that he was involved in the fight. So, I stopped my unit, uh, get out of the car, and that's the first subject that I spoke to, and as he was walking down the sidewalk by the drive, the drive-in lane, or the drive-thru lane, uh, I told him to sit on the curb. He gave me kind of a dirty look, and said, why do I have to get on the curb? That's when I get my Taser out, out of my, uh, Taser holster with my left hand. I start to point it at him thinking that he was just involved in a fight, and he probably wasn't going to cooperate with me, and I told him again, again to sit on the curb. At that time, to the right of me, I see two other male subjects, uh, one chasing another, uh, I'll call the person in the front the victim, the person behind him the suspect. They were running, also, eastbound on the sidewalk in front of the restaurant, and they, uh, the victim, who was in front, actually was running towards me and falls right into a planter, I don't know, about approximately six feet in front of me into a planter to the right. Uh, so, I diverted my attention, uh, and, and when the victim fell, the subject, uh, jumped on top of him, and it appeared to me that he started punching him on, in the back. I diverted my attention to the victim and suspect. They

were in a planter, and I was on one side of the planter, so I actually went to walk around the planter to get behind them. Uh, I still had my Taser in my hand, uh, as I was walking around, I still thought that the suspect was punching the victim. As I walked closer, instead of a punching motion, I saw that the suspect was holding a knife, and he was stabbing him in a stabbing motion in the back. As I saw that, I thought that the suspect was actually killing the victim right in front of me. I already had my Taser in my left hand, and I knew I had to stop the suspect, who was on top of the victim because I had the Taser in my left, it was already out. I tried to shoot it, and it didn't work. At that time, Sergeant Barron and, uh, Officer Jurado came from the east and was actually, uh, positioned in front of the victim and suspect, and as far as I can remember, they were yelling either "stop" or "drop the knife." I can't, can't really remember which one it was. It could have been both. So, there in front of the, the, uh, suspect and victim, as the suspect was stabbing the victim, they're yelling at him. I realize the suspect is not complying; he's still stabbing the victim. My Taser's not worked, so I draw my, uh, my handgun because I have to, I have to stop the suspect from killing the victim. As I'm drawing my handgun, the suspect gets up off the victim. When he's on the ground, I see he has a knife. He takes a couple steps back off the victim, and in one fluid motion, he's still getting up, he still has the knife. He takes a step with his back towards me, he starts to turn around with the knife and coming in my direction. As far as I remember, I was proximately about three feet, four feet from him as he's coming around turning towards me, and he's turning towards me. Based on the close proximity, I thought he was going to engage me with his knife. He still wasn't complying with Sergeant Barron's commands. Due to the fact he was close, he still had the knife, and he was coming my direction, I thought I was going to get engaged and stabbed and possibly killed. At that time I was taking out my gun, and I shot the suspect once. Uh, immediately after I shot the suspect, I heard a shot coming from Sergeant Barron's direction, and the suspect dropped. Uh, the suspect dropped. I actually got the first person that I engaged, I think it was the employee because he was still over there. I told him to get down on the ground and proned him out, and at that time, uh, Officer Jurado and Of-and Sergeant Barron would cuff the victim and the suspect because we didn't know who was, if there was more suspects, if, what was going on. And then somebody else had came up, handcuffed the, uh, third person.
