DETAILS: On 11-22-19, I was employed as a Peace Officer for the City of Corona; County of Riverside, and was wearing a full police uniform and driving a marked black and white police car (unit #79270).

On 11-22-19 at approximately 1623 hours I was working as a Police Officer in the City of Corona, County of Riverside. I was dispatched to the 900 block of Sheridan Street reference a suspicious male. The male (later identified as Francisco Salazar) was described as having no shirt on and wearing black pants. The reporting party stated he hopped a fence to a near-by residence.

I located Francisco on the 900 block of Sheridan. While speaking to Francisco I noticed his speech was rapid, non coherent and quiet. Francisco appeared to not be able to sit still and was very fidgety. Based on the totality of his actions I believed Francisco to be under the influence of narcotics.

While I was speaking with Francisco he stood up, and started to walk backwards away from me. He put his right hand in his right pocket. I told him to sit down. He did not comply. Francisco clenched his fists and squared his body off to mine in an aggressive fighting stance. Prior to making contact I took the following into consideration:

1. Francisco was given lawful commands and was detained due to my investigation of a possible trespassing and due to Francisco giving the signs of being under the influence of a controlled substance. Francisco knew I was a police officer. I told him to sit down twice, and he stated "No, for what?"
2. Francisco had not yet been positively identified, and the danger to myself and the public was unknown.
3. Francisco had not been searched.
4. Francisco was wearing baggie pants, which were large enough to conceal weapons in the pockets.
5. Francisco squared off to me, and took a fighting stance.

I approached Francisco and attempted to grab him to control him. He reached out with both hands in an attempted to grab my chest area. As I was attempting to take Francisco to the ground I could feel him grabbing at my belt, which holds several non-lethal and lethal weapons. At that time I felt I needed to immediately control Francisco, fearing he would take one of my weapons away and use it against me, my partner, or the public.

I was able to grab his right hand and take him to the ground. He tensed his body and attempted to free himself from my grasp. We both landed on our right side on the ground. Francisco was behind me, with me holding his right arm. Once on the ground, I lost control of his right hand, and spun to face him. I attempted to gain control of his hands but was unsuccessful due to him actively pulling away.

I was able to gain control of his left hand and roll Francisco to his stomach. Once Francisco was on his stomach I maintained control of his left. While Francisco was on the ground he repeatedly attempted to grab my hand and my fingers. I told him several times he was under arrest, to stop resisting, and to place his right hand behind his back. Officer Rael was able to apply the carotid restraint. Once Francisco lost consciousness I was able to grab his right hand and place him in handcuffs.

Francisco was searched and taken to Corona Regional Hospital for and Ok-to-Book. Once he was medically cleared, he was taken to RCJ for booking on the listed charges.

During the incident I sustained an abrasion on my left fore arm, and an abrasion on my left elbow.

[REDACTED] In the order it states he has to stay 100 yards away from the residence. The order was issued 03-29-17 and expires 03-29-2020. He was within that yardage when I contacted him.

Francisco was charged with 11550(a) H&S, 69 PC, and 273.6 PC.

On 11/22/19 at 1623 hours, Officers responded to the area of Tenth Street and S. Sheridan Street reference a suspicious person. Officers contacted and later arrested Francisco Salazar (see initial report for details). I responded and spoke to the initial caller, [REDACTED]. The following is a summary of the statement he gave.

[REDACTED] stated he lives on the south east corner of Tenth and Sheridan. He stated the last few days Salazar has been acting like he is under the influence of drugs. He stated he has seen him doing hand to hand drug deals and he has been suspiciously walking around the neighborhood. He stated he called the police on Salazar last night because he was acting suspicious walking around the neighborhood.

[REDACTED] stated today, he saw Salazar jump the fence to his parent's house and wash his body with the hose. He stated he thought Salazar's parents had a restraining order against him because he has caused so many problems at his parent's house. He stated after he saw him washing his body with his parent's hose, he went out to the sidewalk and started to do push-ups. He stated Salazar was doing push-ups for 20-30 minutes until he had to leave the area.

[REDACTED] stated he was gone when the confrontation between Salazar and the officers occurred. He stated he was not surprised officers had to struggle with him because he suspected him of being under the influence of drugs.

Officer: Rozzy Rael - 003101

On November 22, 2019 at approx. 1623 hrs. I responded to Sheridan and Tenth Street to assist Ofcr. Tarrant with a suspicious person, later identified as Francisco Salazar. Ofcr Tarrant contacted Francisco prior to my arrival. During this time, I was wearing a clearly marked Corona Police uniform driving a marked Corona Police unit #79276.

Upon arrival I observed Francisco, who was not wearing a shirt, stand up and put his right hand in his right pocket for unknown reasons. I heard Ofcr Tarrant tell Francisco to sit back down, which he did not comply. Francisco then backed up, clenched his fist, and squared his body up to Ofcr Tarrant. Ofcr Tarrant then advanced towards Francisco, at which point Francisco attempted to grab Ofcr Tarrant's chest area. I then saw Francisco wrap both of his arms around Ofcr Tarrant's torso area, at which point Ofcr Tarrant grabbed Francisco's right arm and took him to the ground.

After Francisco and Ofcr. Tarrant fell to the ground Francisco continued to struggle as he landed on his right side, at which time I took this opportunity to place him in the carotid restraint hold.

Prior to placing Francisco in the carotid restraint hold I took the following into consideration:

- 1) Ofcr. Tarrant and I were investigating a report of a suspicious person, who matched the description of a suspicious person call received last night in the same area. Francisco was acting erratic and unpredictable.
- 2) Francisco had not been checked for weapons.
- 3) Francisco was actively resisting by not complying to Ofcr. Tarrants requests as he violently struggled to escape his holds.
- 4) Once on the ground Francisco refused to place his hands behind his back and continued to resist.
- 5) I thought Francisco was going to batter myself and/or Ofcr Tarrant if not immediately taken into custody.

After applying the carotid restraint, Francisco lost consciousness momentarily. I then gradually released the pressure of the hold while maintaining control, which allowed Ofcr. Tarrant to safely place him in handcuffs. Once handcuffed Francisco began to slowly recover. Francisco was later transported to Corona Regional Hospital by Ofcr Tarrant for an O.K. to book.

On 11/22/19 at 1623 hours Officers responded to the area of Tenth Street and S. Sheridan Street reference a suspicious person. Officers contacted and later arrested Francisco Salazar (see initial report for details). I responded to speak with Salazar's mother, [REDACTED] due to her only speaking Spanish.

[REDACTED] stated she did not see what had occurred, but insisted that Salazar did not do anything wrong. [REDACTED] said Salazar was seated at the southeast corner of the intersection when she walked into her residence [REDACTED] [REDACTED] heard screams and when she walked out of her home Salazar was on the ground and being taken into custody.

[REDACTED] willingly provided me with her name and birthdate. She said her name was [REDACTED] and her birthdate was [REDACTED] [REDACTED]

[REDACTED] Three served restraining orders were located (RIM1809913, RIM1704316, RIM1703102) prohibiting Salazar from being within 100 yards of [REDACTED] Two of the orders listed the protected party as [REDACTED] with a date of birth of [REDACTED] and one of the orders (RIM1704316) listed [REDACTED] as the protected party with a date of birth of [REDACTED]

[REDACTED] stated she was aware of the restraining orders but said she never served Salazar [REDACTED] [REDACTED] did not desire prosecution for violation of the orders.
