RE: Second Notice: Regional Council District #63 Representative Election

This is to notify all Mayors and Councilmembers of SCAG’s Regional Council (RC) District 63 that after the Call for Candidates closing date of January 23, 2023, SCAG received two (2) declarations of candidacy from the following:

1. The Honorable Tony Daddario, Corona
2. The Honorable Steve Manos, Lake Elsinore

According to SCAG Regional Council Policy Article V, Section 8, if there are two (2) or more candidates received by the deadline date, a district election will be held by member cities within the RC District

Please be advised that the District Election as noted in the 1st Notice, is scheduled for:

Date: Thursday, February 13, 2023
Time: 6:00 p.m.
Location: **[Virtual link to be provided prior to election]**

Term of Office: May 2023 to May 2025.

District Election Procedures

- District Elections organized under Option “B” will be scheduled, administered, and conducted by SCAG staff utilizing SCAG’s RC District Election template language. SCAG will keep the Subregion updated on RC District Election process.

- District Elections shall be held in conjunction with meetings of subregional organizations or the League of California Cities or at other times and locations identified by SCAG staff.
- District Representatives shall be elected by a majority of the votes of those city council members present from voting-eligible cities with a quorum.
- A quorum shall consist of at least one (1) city council member present from at least two-thirds of the voting-eligible SCAG member cities in a District. For example, if District X is comprised of four member (4) cities, then at least one (1) local elected official from four (4) of the member cities within District X must be present to constitute a quorum. When a quorum is present, the election may be conducted.
- Nominations from the floor shall not be permitted.
- Proxy voting is not allowed.
- Teleconferencing is allowed. This election will be conducted virtually.
- In the event of a tie vote, additional balloting shall occur until a District Representative is elected.
- Elected officials from cities that are not voting-eligible members of SCAG cannot vote and cannot be candidates for District Representative positions.
- If there is only one candidate, that individual shall be declared the District Representative and no election will be required.

Given the declared state of emergency (pursuant to State of Emergency Proclamation dated March 4, 2020) and local public health directives imposing and recommending social distancing measures due to the threat of COVID-19, and pursuant to Government Code Section 54953(e)(3), the Regional Council District elections are currently being conducted electronically and telephonically until further notice.
