

Historical Society of Corona (Jean C. Bobbitt) Collection

The Andrew Carnegie Library of Corona closed its' doors on 3 July 1971, having served the community well for 65 years. Corona City Council then had to decide what to do with the building, which needed to be brought up to code. An Ad Hoc Committee was formed with members of the Corona Art Association, Woman's Improvement Club, Chamber of Commerce, and interested individuals from the community. Jean C. Bobbitt was one of those individuals.

In July 1972 a group of individuals, mainly from the Ad Hoc group to 'Keep Our Old Library', formed the Historical Society of Corona. Jean C. Bobbitt was elected their first President. Their first project was to take the lead in the attempt to save the old library. These efforts were spearheaded by the President of the newly formed Historical Society of Corona, Jean C. Bobbitt. Recognition of her efforts were noted by many, resulting in her being elected to be the first President of the Riverside County Historical Society Historical Congress on October 1, 1977. Jean C. Bobbitt tendered her resignation as President of the Historical Society of Corona on 25 October 1977, having served since July 1972. No one stepped up to take her place at the Historical Society and the organization was dissolved.

Collection Description:

The *first series* includes records that document the formation and growth of the Historical Society of Corona in July 1972 until July 1974, most of the effort was on getting the society organized, writing bylaws, recruiting new members, and gaining official recognition.

The bulk of correspondence in *Series 2* pertains to efforts to save the old library. The effort started in earnest in July 1974 and continued until the Corona City Council sold the building in February 1978. The building was completely torn down by May 1978, thus ending a seven year struggle to 'Keep Our Old Library'.

The remainder of the collection covers the work of Jean C. Bobbitt in support of the Corona Bicentennial and the World Farm Foundation. She was also involved in the Riverside County Historical Congress in 1977, and became their first president.

The *last series*, The Woman's Improvement Club, illustrates Bobbitt's efforts working on historical sites through the Woman's Improvement Club, De Anza District #23.

This collection is a valuable resource as to how and why the Historical Society of Corona was formed. Contained in this collection is extensive correspondence pertaining to the attempt to save the Andrew Carnegie Library Building located on Eighth and South Main Streets.
