Noah Smith Joseph was born in 1838 in Ohio. He married Susan Busbee in 1866. They had nine children, 7 sons and 2 daughters. He moved his family to Corona in 1889. He moved into a mountain ranch in what is now the "Joseph/Fisher Canyon." In 1900, a company of Seventh-day Adventists was organized in his home in Corona. He died on May 1, 1911. His oldest child and daughter, Anna Lula Joseph Ritchie was born on December 15, 1867. She was a missionary and pastor for before her marriage to William Shannon Ritchie on February 23, 1900. They lived on Vicentia between 7th and 8th Streets in Corona in a house built from redwood timbers recycled from a church in Wildomar and after WWII; timbers were recycled again into 5 homes on the southwest corner of Vicentia and Seventh streets. Their home was used for Sabbath services for Seventh-day Adventists. Anna Lula Joseph Ritchie died on September 26, 1948. The youngest child and second daughter, Della May Joseph was born March 11, 1886. She married Frank Fisher. They lived in Joseph Canyon for many years. She died on May 1, 1965. The family also ran the Wildwood Glenn.
