The origins of the Corona Municipal Court date to the founding in 1905 of the Temescal Judicial District. The district provided court services for the Rincon and Temescal townships. On November 10, 1961 the Corona Judicial District was formed and the Corona Municipal Court opened on 505 S. Buena Vista Avenue. A traffic court was added in 1987 to handle the 2,400 traffic cases that came from the Corona area each month. In 1992, the County Board of Supervisors merged the Corona Municipal and Riverside County Municipal Court. Services were altered after the merger, misdemeanor cases would remain in Corona but felony cases were moved to the court in Riverside. Services were expanded in January 1994 to include a family law session. Each Tuesday the Corona Municipal Court handled alimony, custody visits, and child support cases. That same year the Riverside Municipal and Superior Court systems merged. The consolidated court system expanded services at Corona Municipal Court to include superior court civil and family court filings. Budget cuts lead to the closure of Corona Municipal Court on July 1, 2003.


