The Wyle Laboratories site is located at 1841 Hillside Avenue in the City of Norco, Riverside County, California. The geographic coordinates for the site are 33° 54'30" north latitude and 117° 32'32" west longitude. The site is composed of approximately 429 acres and is bordered on the north by a residential area and the west by Hillside Avenue, Norco Senior High School, and residences. The site is bordered on the south by El Paso Drive and residences and on the east by the Hidden Valley Golf Course.

The Wyle site operated as a commercial testing facility since 1957 for a number of markets including defense. The site was identified as a potentially hazardous waste site and entered into the Comprehensive Environmental Response, Compensation, and Liability Information System (CERCLIS) on December 1, 1987. The U.S. Environmental Protection Agency (EPA) conducted a Preliminary Assessment (PA) in 1988 and made a No Further Remedial Action Planned (NFRAP) decision in December 1988. Due to community concerns and new information, EPA decided to reassess the Wyle site in April 2003. The units tested may have contained hazardous substances such as hydrazine, perchlorate, and/or nitrosodimethylamine (NDMA). In addition to testing, Wyle conducted degreasing operations, suggesting a possible release of volatile organic compounds (VOCs) such as tetrachloroethene (PCE) and trichloroethene (TCE). Chemical analyses of groundwater samples collected from beneath the site from April 1999 through the present indicated the presence of VOCs, hydrazine, NDMA, and perchlorate at concentrations exceeding three times the concentrations found in an upgradient monitoring well. Chemical analyses of on-site soil samples collected during 1999 and 2002 sampling events indicated the presence of VOCs, hydrazine, polychlorinated byphenyls (PCBs), and lead.

Arrow Electronics, Inc., the parent company and previous owner, sold the site to CRV-SC Norco Partners L.P. (St. Clair) and closed Wyle's Norco facility in 2004. St. Clair plans to develop the site for approximately 368 single-family homes.
