Francisco Serrano (II) Collection

1888-2004 (bulk 1892-1916) Textual documents, 2 books – one box, 5 linear inches

Francisco Serrano (II) was born in 1844 at Rancho Canada de los Alisos (what is now El Toro, California) to Jose Antonio Serrano and Petra Avila Serrano. Jose Serrano was the younger brother of Leandro Serrano, the first to build a permanent house in Riverside County and the son of Francisco Serrano (I) who was born in Aragon, Spain in 1745 and who came to Mexico with a Spanish expedition.

In 1879 Francisco (II) and Concepcion (Aros) Serrano moved their family to Prado and established the Serrano Ranch. After the move to Prado Francisco opened a general store in the area and a combination general/hardware store in Corona (on Main Street between 4th & 5th Street). Francisco and Concepcion lived in Prado until their deaths in 1922 and 1938. The family resided at the home they built until the Army Corps of Engineers began construction of the Prado Dam in 1938.

The collection consists of business records such as order forms and receipts related the daily life of Francisco Serrano's ranch and stores. Some familial and social records are contained in the collection, invitations to dances and weddings for example. The significance of the collection resides in the slice of life it provides about an early California and Riverside County family and how business was conducted on ranches and retail stores in the region.
