R.H. Verity, Sons and Company emerged from a business founded in the early 1900s by A.F. Call. Call named the business Call Lemon Association. After Call's death in 1913, two long-time stock holders, G.A. Charters and Allen J. Davis purchased the business outright and renamed it Charters-Davis Company. Charters served as the company's president. Davis, who had been the Call Lemon Association's general manager, continued in this capacity, as well as holding the offices of vice president and treasurer. When the business changed ownership in 1918, it consisted of 212 acres of citrus fruits and 108 acres of peaches, plums and alfalfa. The company also held a 10 year lease on 22 acres of oranges and owned a packing house near Ontario and Compton streets which was erected in 1913. On December 1, 1929, the company's name was changed to Davis-Verity as Charters no longer held an interest in the business. In 1932, R. H. Verity, his wife, Helen F., his wife's sister Katherine E. Burritt, and his sons, Wilfrid Burritt, Alden Henry, and Robert Charles purchased Davis' interest in the company and renamed it, R.H. Verity, Sons and Company. The business now owned 250 acres of groves, rented another 60 acres. It owned a citrus packing house and offices located on East Ontario and Compton streets. That year, the company shipped 150 railroad cars of citrus (100 contained lemons).

During the 1930s because marketing regulations limited how much fruit could be sent to market in any given year, the Veritys constructed a lemon storage building in 1941 to store their fruit. During World War II, obtaining necessary supplies such as shook for citrus crates or bags for citrus picking became a problem. In March 1948, in response to falling citrus prices, the Veritys closed their packing house. From 1948 to 1977, Verity and Sons contracted to have their citrus picked, packed and marketed by Corona Foothill Lemon Company and the Orange Heights Orange Association. With rising land values and increasing urban and suburban development, the Veritys sold their grove acreage in 1958 and eventually also the packing house. By 1978, all of the R.H. Verity Sons and Company assets had been liquidated.

The collection consists of partnership records, property records (1958-1978), financial records (19730-1977), ledgers, legal records (1938-1978), sales record (1931-1948), pool statements (1948-1977), association records (1932-1977), citrus marketing records, labor records (1940-1949), physical plant records, correspondence (1932-1975), bulletin, circulars, newsletters (1913-1950, mostly 1930-1959).

Series:

1) **Financial Records** include records appraising the Verity business, listings of assets and liabilities, audit and financial statements, county tax statements, insurance records and estate records of deceased partners.

- 2) **Legal Records** contain correspondence on legal matters relating to partnership agreements, estates of deceased partners, trademark registration, trespassing on grove property.
- 3) **Property Transaction Records** includes information about property easements, rights-of-way, leases for oil and gas exploration and billboards. The major portion relates to property sales.
- 4) Citrus Sales Records Account Sales records cover the period 1931 to 1948 when Verity packed and shipped their own fruit to the fruit auctions in Chicago. Each car lot sent to Chicago represented one railroad car filled with citrus crates. Each car lot was assigned a file number. Each File contains such records tally sheets counting crates packed into the railroad car, shipping invoices, bills of lading, citrus inspection reports, correspondence with various fruit distributors, auction reports and citrus sales invoices. -- Pool Statements detail marketing of the citrus fruit through cooperative citrus marketing associations and contain information on the rates associations charged growers for picking, packing and marketing citrus fruit as well as certain grove maintenance operations. The statements detail income earned.
- 5) **Association Records** contain association bylaws, newsletters, annual reports, agreements, and correspondence. Included are files on various cooperative citrus marketing associations, professional associations and other types of agricultural associations.
- **6) Citrus Marketing Records** are more general records such as citrus labels, Chicago Sales information, marketing agreements, estimates of prices and shippers' performance records.
- 7) **Labor Records** consist of lists of employees, hourly rate information, daily payroll records, time records, savings bond records, compensation records and correspondence with and about employees.
- **8) Physical plant records** deal with groves, packing house and lemon storage house, supplies, equipment, wells, pumps and irrigation.
- 9) Correspondence, Business and Personal related to business matters along with a few personal letters. Most relate to partnership dividends, estate matters and questions about citrus growing.
- 10) Bulletins, Circulars, Newsletter published by agricultural entities.
